Monthly Investment Highlights

- The Company produced a total NAV return of 1.38%, surpassing last month's record return of 1.03%, for the strongest total NAV return since inception
- The gross revenue return was 1.12% and total net revenue return was 0.99%
- Capital returns for the month were 0.39%, driven by valuation increases on two of the Company's equity positions

Monthly Commentary

During June, the Company continued to produce both strong revenue and capital returns. The strong capital returns had two major drivers as outlined below:

- Elevate's stock price (NYSE: ELVT) continues to appreciate as the management team executes on its strategic plan; and
- An upcoming Series B investment at a higher value than the previous round by a leading technology investor into one of the platforms held by the Company.

During the month, the Company also increased its first out participations from a US bank on both the Company's Avant and Elevate balance sheet investments, slightly increasing the look-through gearing ratio and giving the Company proceeds of \$7.2 million, which were subsequently reinvested into other balance sheet investments. The look-through gearing ratio increased slightly to 0.15x as at 30 June 2018 from 0.14x as at 31 May 2018.

During June, the Company did not repurchase any shares under the share buyback program.

Events Subsequent to 30 June 2018

On 2 July 2018, the Company was fully repaid on its balance sheet investment to Wheels Financial Group, LLC, which comprised 5.11% of the Company's NAV as at 30 June 2018. The early repayment of this investment came with a prepayment penalty fee of \$220 thousand (0.05% of NAV) which was recognised by the Company in June. The Company has redeployed substantially all the proceeds from the investment into new and existing balance sheet investments.

From 1 July 2018 through 27 July 2018, the Company did not repurchase any shares under the share buyback programme. The Company continues to be nearly fully invested.



Company Overview

VPC Specialty Lending Investments PLC ("VSL" or the "Company") invests in opportunities within the financial services market primarily through balance sheet or marketplace lending models ("Portfolio Companies"). The Company completed its IPO on 17 March 2015 with a premium listing on the Official List of the U.K. Listing Authority and trading on the Main Market of the London Stock Exchange. The Company's trading symbol is VSL for the Ordinary Shares.

The Company's investment manager is Victory Park Capital Advisors, LLC ("VPC" or the "Investment Manager"). VPC is an SEC-registered investment adviser and acts as the AIFM of the Company.

Since 2010, the Investment Manager has been actively involved in the specialty lending marketplace and has made more than \$6.0 billion of investments and commitments across various financial technology Portfolio Companies, spanning multiple geographies, products and structures, and continues to deploy capital into existing and new Portfolio Companies.

The Company's Investment Objective

Increased banking regulation (particularly in Europe and the U.S.) is imposing restrictions on certain types of lending by banks to both consumers and small businesses, leading to a growing market for specialty lending Portfolio Companies. The online lending market continues to expand rapidly as both borrowers and investors recognise the advantages relative to the traditional bank lending model.

The Company seeks to generate an attractive total return for shareholders consisting of dividend income and capital growth via investments across a diverse portfolio of various online lending providers, asset classes, geographies (primarily U.S., U.K., Europe and Australia) and credit bands.

The Company generates investment income from exposure to Portfolio Company-originated consumer and small business loans, including corporate and trade receivables, in accordance with certain investment limits and restrictions to ensure diversification of the Company's portfolio is maintained and that concentration risk and credit exposure is mitigated. In addition, the Company may also make direct equity investments, or receive warrants to purchase equity stakes, in such Portfolio Companies.
