

Monthly Report – November 2022

Monthly Investment Highlights

- For the month of November, the Company generated a gross revenue return of 1.17% (1.19p), a gross capital return of -0.58% (-0.59p), and a total NAV return of -0.25% (-0.25p);
- The impact of expenses and fees during the month was -0.39% (-0.40p), and other capital returns were -0.45% (-0.45p);
- The average interest rate on the portfolio was 13.9%, up from 13.3% in October 2022.

Monthly Commentary

The Company's gross revenue return for the month was 1.17% (1.19p). The Company's asset-backed investments continue to perform in line with expectations and similar to the last few months, short-term interest rates continued to rise, leading to increased gross revenue returns for the quarter. For the month, the average interest rate on the portfolio was 13.9%, compared to 13.3% in October 2022.

The main driver of the negative gross capital return for the month was due to the decrease in the publicly traded price of the Company's public investments, which contributed -0.46% to the monthly returns. In addition, the Company increased its IFRS reserves for the month of November which contributed -0.14% to the monthly returns.

On 30 November 2022, the Company declared its 19th consecutive dividend of 2.00 pence per share for the three months to 30 September 2022.

During the month, the Investment Manager purchased 56,197 shares of the Company with 20% of its monthly management fee following the announcement of the September NAV.

Events Subsequent to 30 November 2022

On 22 December 2022, after further consultation with its major shareholders, the Board determined that it would be in the best interests of the Company and shareholders to put forward formal proposals to shareholders for a managed wind-down of the Company instead of the 25% exit opportunity. With the announcement of the October NAV, the Investment Manager purchased 55,478 shares of the Company with 20% of its monthly management fee.

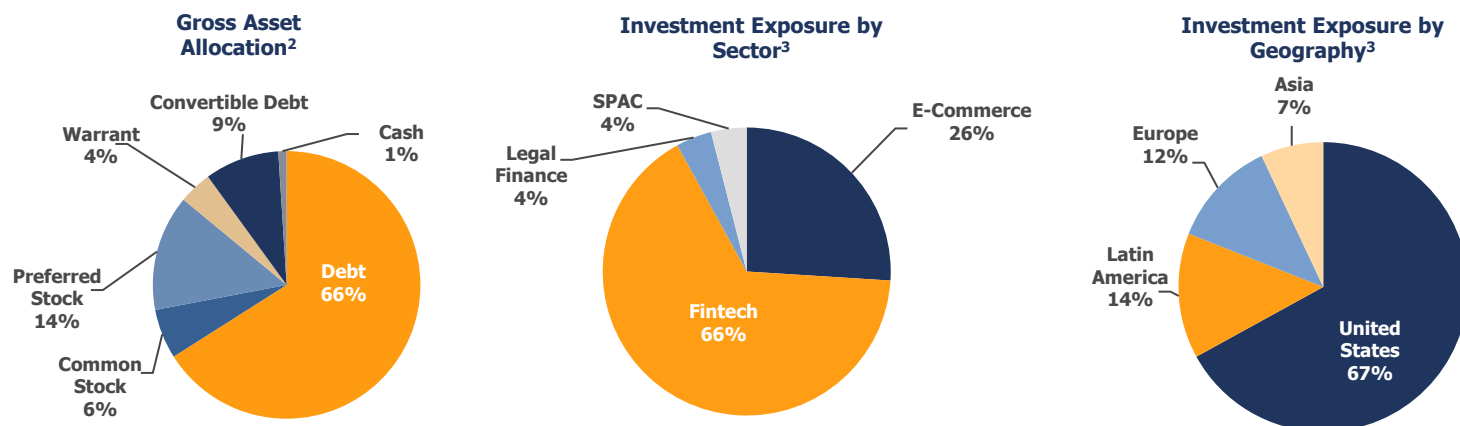

Company Overview

VPC Specialty Lending Investments PLC (“VSL” or the “Company”) is a UK-listed investment trust focused on asset-backed lending to emerging and established businesses (“Portfolio Companies”) with the goal of building long-term, sustainable income generation. VSL identifies investment opportunities across various industries and geographies to offer shareholders access to a diversified portfolio of opportunistic credit investments, originated by non-bank lenders with a focus on the rapidly developing technology-enabled lending sector. The Company completed its IPO on 17 March 2015 with a premium listing on the Official List of the U.K. Listing Authority and trading on the Main Market of the London Stock Exchange. The Company’s trading symbol is VSL for the Ordinary Shares.

The Company’s investment manager is Victory Park Capital Advisors, LLC (“VPC” or the “Investment Manager”). VPC is an SEC-registered investment adviser and acts as the AIFM of the Company.

Since 2007, the Investment Manager has been actively involved in the specialty lending marketplace and has made more than \$8.8 billion of investments and commitments across various financial technology Portfolio Companies, spanning multiple geographies, products and structures and continues to deploy capital into existing and new Portfolio Companies.

VPC identifies and finances emerging and established businesses globally and seeks to provide the Company with attractive yields on its portfolio of credit investments. VPC offers a differentiated private lending approach by financing Portfolio Companies through asset-backed delayed draw term loans, which is referred to as “Balance Sheet Lending.” Balance Sheet Lending affords various structural protections and covenants which are designed to limit downside risk while providing shareholders with strong income returns.
