Monthly Investment Highlights

- For the month of April, the Company generated a gross revenue return of 1.38% (1.30p), a gross capital return of -0.57% (-0.54p), and a total NAV return of 0.34% (0.32p); and
- The impact of expenses and fees during the month was -0.42% (-0.40p), and other capital returns were -0.05% (-0.05p).

Monthly Commentary

The Company's gross revenue return for the month was 1.38% (1.30p). The average interest rate on the portfolio was 15.23%. The Company's gross capital return for the month was -0.57% (-0.54p). The gross capital return was primarily driven by changes to the market prices in the Company's publicly traded investments (-0.43%).

On 28 April 2023, the VSL Annual Report was published to the Company's website.

Events Subsequent to 30 April 2023

On 16 May 2023, the General Meeting Circular was announced and published to the Company's website, inclusive of two proposals for the Company's managed wind-down. A vote on the two proposals will take place on 12 June 2023.

Heading into the vote on the proposed wind-down of the Company, whilst precise timings and other aspects will be subject to commercial factors and the borrowers' ability to meet their obligations at the relevant time, approximately 70%³ of the Company's asset-backed lending investments, by value, falls due for repayment by the end of 2024 with the remaining 30%³ due for repayment by the end of 2026. Whilst there is no guarantee or assurance that the repayment schedule will follow this pattern, proceeds of repayment, after repaying the leverage facility to reduce gearing, will be applied as described in the Circular seeking to balance the optimum scale and accompanying costs to the Company of the relevant method of return with the desire to accomplish that return as quickly as practicable, without eroding the value to be distributed. Net proceeds will also be distributed with a view to maximising the proportion of shareholders receiving such proceeds. For instance, if this is by way of tender then it would be hoped that capital returns are made at a level at or around NAV.

On 31 May 2023, the recurring Annual General Meeting ("AGM") Circular was announced and published on the Company's website. The announcement contained an update on upcoming Board membership changes for Elizabeth Passey and Clive Peggram. Ms. Passey and Mr. Peggram have served on the Board since the launch of the Company and are in their ninth year as directors. In line with best practice in corporate governance relating to tenure, they have advised the Company of their intention not to stand for re-election at the forthcoming AGM. The AGM will take place on Friday, 23 June 2023.



Company Overview

VPC Specialty Lending Investments PLC (“VSL” or the “Company”) is a UK-listed investment trust focused on asset-backed lending to emerging and established businesses (“Portfolio Companies”) with the goal of building long-term, sustainable income generation. VSL identifies investment opportunities across various industries and geographies to offer shareholders access to a diversified portfolio of opportunistic credit investments, originated by non-bank lenders with a focus on the rapidly developing technology-enabled lending sector. The Company completed its IPO on 17 March 2015 with a premium listing on the Official List of the U.K. Listing Authority and trading on the Main Market of the London Stock Exchange. The Company’s trading symbol is VSL for the Ordinary Shares.

The Company’s investment manager is Victory Park Capital Advisors, LLC (“VPC” or the “Investment Manager”). VPC is an SEC-registered investment adviser and acts as the AIFM of the Company.

Since 2007, the Investment Manager has been actively involved in the specialty lending marketplace and has made more than \$8.8 billion of investments and commitments across various financial technology Portfolio Companies, spanning multiple geographies, products and structures and continues to deploy capital into existing and new Portfolio Companies.

VPC offers a differentiated private lending approach by financing Portfolio Companies through asset-backed delayed draw term loans, which is referred to as “Asset Backed Lending.” Asset Backed Lending affords various structural protections and covenants which are designed to limit downside risk while providing shareholders with strong income returns.
