ANNUAL GENERAL MEETING 2024

I am pleased to enclose the Notice of Annual General Meeting (the "AGM") of VPC Specialty Lending Investments PLC (the "Company"), which will be held at 2 p.m. on Wednesday, 12 June 2024 at the offices of Stephenson Harwood LLP, 1 Finsbury Circus, London EC2M 7SH. The formal notice convening the AGM (the "Notice of AGM" or "Notice") can be found on pages 6 to 7 of this document which sets out the business to be considered at the AGM. The purpose of this letter is to explain certain elements of that business to you.

MEETING ARRANGEMENTS

All shareholders are welcome to attend the meeting in person and we ask that any shareholders wanting to do so register their interest in attending by emailing VPC@linkgroup.co.uk.

Shareholders are encouraged to raise any issues they have with the Company in advance of the meeting. In addition, shareholders unable to physically attend and who wish to ask any questions at the AGM should do so in writing to the Company Secretary, Link Company Matters Limited at 6th Floor, 65 Gresham Street, London EC2V 7NQ or by email to VPC@linkgroup.co.uk so as to be received by the Company Secretary no later than 2 p.m. on Monday, 10 June 2024. If appropriate, the Company will publish a list of responses on its website at https://vpcspecialtylending.com after the AGM.

VOTING ARRANGEMENTS – ACTION TO BE TAKEN

If you would like to vote on the resolutions to be proposed at the AGM and you hold your shares in certificated form, you may appoint a proxy electronically at www.signalshares.com by following the instructions on that website or, if you hold your shares in CREST, you may appoint a proxy via the CREST system. Notice of your appointment of a proxy should reach the Company's registrar, Link Group (the "**Registrar**") by no later than 2 p.m. on Monday, 10 June 2024. If you hold your shares through a nominee service, please contact the nominee service provider regarding the process for appointing a proxy. Further details and instructions regarding the appointment of a proxy are set out in the "Administrative Notes" in connection with the AGM on pages 8 to 10 of this document.

The Board strongly encourages shareholders to vote electronically and to appoint the Chair of the meeting as their proxy with their voting instructions.

POLL VOTING

Each of the resolutions to be considered at the AGM will be voted on by way of a poll. This ensures that shareholders who are unable to attend the AGM but who have appointed proxies have their votes taken into account. The results of the polls will be announced to the London Stock Exchange and published on the Company's website as soon as possible after the conclusion of the AGM.

RESOLUTIONS

Resolutions 1 to 10 will be proposed as ordinary resolutions. An ordinary resolution requires a simple majority of votes cast, whether in person or by proxy, to be cast in favour of the resolution for it to be

passed. Resolutions 11 to 13 will be proposed as special resolutions. A special resolution requires a majority of not less than 75% of the votes cast, whether in person or by proxy, to be cast in favour of the resolution for it to be passed.

ORDINARY RESOLUTIONS

Resolution 1 – To receive, consider and approve the Annual Report and Financial Statements

The Directors are required to present the annual report and audited financial statements, which incorporate the Directors' Report and Auditor's Report, to the meeting. These are contained in the Company's Annual Report and Audited Financial Statements for the year ended 31 December 2023 (the "Annual Report").

Resolution 2 – Directors' Remuneration Report

In accordance with the requirements of the remuneration reporting regime which came into force on 1 October 2013, the Board is required to give notice to shareholders of the intention to propose an ordinary resolution to approve the Directors' remuneration report for the financial year ended 31 December 2023. This is an advisory resolution and is, therefore, not binding.

The Directors' remuneration report is set out in the Annual Report.

Resolution 3 – Dividend Policy

Under the Company's Articles of Association (the "Articles"), the Board is authorised to approve the payment of interim dividends without the need for the prior approval of the Company's shareholders. However, having regard to corporate governance best practice relating to the payment of interim dividends without the approval of a final annual dividend by a company's shareholders, the Board has decided to seek express approval of its dividend policy, set out on page 16 of the Annual Report. The Company's dividend policy remains unchanged to that disclosed in the IPO prospectus published on 26 February 2015 which stated that the Company intends to distribute at least 85% of its distributable income earned in each financial year by way of dividends and that such dividends are intended to be paid quarterly.

Shareholders should note that the dividend policy is not a profit forecast and dividends will only be paid to the extent permitted in accordance with the Companies Act 2006 ("Companies Act").

Resolutions 4 to 6 - Re-election of Directors

Under the Company's Articles, each Director must retire from office at the first AGM following their appointment and stand for election. They must then stand for re-election at the third annual general meeting after an AGM at which they were last elected should they wish to serve for a further term. Notwithstanding this, the Board has decided that all Directors, should be subject to annual election by shareholders and therefore will seek re-election at the AGM.

For further information about the Directors standing for re-election, full biographies of each Director are set out in the Company's Annual Report and is also available for viewing on the Company's website http://vpcspecialtylending.com/.

It is the Board's view that the Directors' biographies illustrate why each Director's contribution is, and continues to be, important to the Company's long-term sustainable success. Each of the Directors standing for re-election has undergone a performance evaluation and has demonstrated that he or she remains committed to the role, has the necessary skills and experience, and continues to be an effective and valuable member of the Board. The Board is content that each Director offering themselves for election or re-election is independent and there are no relationships or circumstances likely to affect their character or judgement. Accordingly, the Board unanimously recommends the election and re-election of the Directors set out in resolutions 4 to 6.

Resolutions 7 and 8 – Re-appointment and remuneration of Auditor

At each meeting at which the Company's financial statements are presented to its members, the Company is required to appoint an auditor to serve until the next such meeting. The Board, on the recommendation of the Audit and Valuation Committee, recommends the re-election of PricewaterhouseCoopers LLP and this will be proposed to the AGM as Resolution 7. Resolution 8 authorises the Audit and Valuation Committee to determine their remuneration.

Resolution 9 - Authority to allot ordinary shares

The purpose of Resolution 9 is to grant the Board the authority to allot ordinary shares in accordance with Section 551 of the Companies Act up to an aggregate nominal value of £278,276 representing approximately 10% of the issued ordinary share capital (excluding treasury shares) at the date of the Notice of AGM. There are currently 104,339,273 shares held in treasury.

Whilst the Directors have no present intention of exercising this authority, they consider it important to have the maximum flexibility commensurate with good corporate governance guidelines, to raise finance to enable the Company to respond to market developments and conditions.

No ordinary shares will be issued for cash at a price less than the prevailing net asset value per ordinary share at the time of issue pursuant to this authority. This authority shall expire at the conclusion of the Company's next annual general meeting to be held in 2025.

The Directors do not intend to allot or sell shares pursuant to Resolution 9 other than to take advantage of opportunities in the market as they arise and will only do so if they believe it to be advantageous to the Company's existing shareholders and when it would not result in any dilution of net asset value per share (owing to the fact that no ordinary shares will be issued or sold for a price less than the prevailing net asset value per ordinary share).

Resolution 10 - Authority to allot B shares

The purpose of Resolution 10 is to grant the Board the authority to allot B shares in accordance with Section 551 of the Companies Act up to an aggregate nominal value of £98,141,001.04 (being the remainder of the aggregate total of £110,000,000.00 that may be allotted (as approved on 5 April 2024), following the allotment of B shares on 19 April 2024) on a pro rata basis to the holders of ordinary shares by way of bonus issue.

The authority will expire at the conclusion of the Annual General Meeting of the Company to be held in 2025. Passing Resolution 10 will ensure that the Board continues to have the ability to issue redeemable B shares to shareholders upon further realisations.

SPECIAL RESOLUTIONS

Resolution 11 – Authority to dis-apply pre-emption rights

Resolution 11 is a special resolution which is being proposed to authorise the Directors to disapply the pre-emption rights of existing Shareholders in relation to issues of ordinary shares under Resolution 9 (being in respect of ordinary shares up to an aggregate nominal value of £278,276 representing up to approximately 10% of the Company's issued ordinary share capital (excluding treasury shares) as at the date of the Notice of AGM).

This authority shall expire at the conclusion of the Company's next AGM to be held in June 2025.

The Directors do not intend to allot or sell shares pursuant to Resolution 11 other than to take advantage of opportunities in the market as they arise and will only do so if they believe it to be advantageous to the Company's existing shareholders and when it would not result in any dilution of net asset value per share (owing to the fact that no ordinary shares will be issued or sold for a price less than the prevailing net asset value per ordinary share).

Resolution 12 - Purchase of own shares

Resolution 12 is a special resolution that will grant the Company the authority to make market purchases of up to 41,713,631 representing approximately 14.99% of the ordinary shares in issue as at the date of the Notice of AGM (excluding treasury shares). The shares bought back will either be cancelled or placed into treasury at the determination of the Directors. There are currently 104,339,273 ordinary shares held in treasury.

The maximum price which may be paid for each ordinary share must not be more than the higher of: (i) 5% above the average of the mid-market values of the ordinary shares for the five business days before the day of purchase; and (ii) the higher of the price of the last independent trade and the highest current independent bid on the London Stock Exchange. The minimum price which may be paid for each ordinary share is £0.01, being the nominal value of an ordinary share.

The decision as to whether to buy back any ordinary shares will be at the discretion of the Board. Ordinary Shares bought back in accordance with the authority granted to the Board will either be held in

treasury or cancelled. If the shares are held in treasury, they may be reissued from treasury but will only be reissued at a price that is in excess of the Company's then prevailing NAV. The Company will fund any buyback by using the Company's cash resources. This authority will expire at the AGM to be held in 2025 when a resolution to renew the authority will be proposed. The ability to undertake share buybacks will be dependent on Resolution 12 being passed.

Resolution 13 – Notice of General Meetings

Resolution 13 is a special resolution that will, if passed, give the Directors the ability to convene general meetings, other than AGMs, on a minimum of 14 clear days' notice (rather than 21 clear days as required by the Company's Articles). In accordance with the requirements of the Company's Articles, the Company will offer shareholders an electronic voting facility at each general meeting convened on such shorter notice period. The minimum notice period for AGMs will remain at 21 clear days, in accordance with the Company's Articles. If passed, this authority would provide the Company with flexibility where the Company needs to take action quickly but will only be used where the Directors consider it in the best interests of shareholders to do so and the matter is required to be dealt with expediently.

This authority shall expire at the conclusion of the Company's next AGM in 2025.

RECOMMENDATION

Full details of the above resolutions are contained in the Notice of AGM. The Directors consider that all the resolutions to be proposed at this year's AGM are in the best interests of the Company and its members as a whole. The Directors unanimously recommend that shareholders vote in favour of all the resolutions, as they intend to do in respect of their own beneficial holdings.

To be entitled to attend and vote at the AGM (and for the purpose of determining the votes they may cast), members must be registered in the Company's register of members at close of business on 2:00 p.m. on 10 June 2024 (or, if the AGM is adjourned, at close of business on the day two days prior to the adjourned meeting). Changes to the register of members after the relevant deadline will be disregarded in determining the rights of any person to attend and vote at the AGM.

9. Votes to be taken by a poll

At the AGM, all votes will be taken by a poll rather than on a show of hands.

It is intended that the results of the poll votes will be announced to the London Stock Exchange and published on the Company's website by 6 p.m. on 12 June 2024. Poll cards will be issued on registration to those attending the AGM.

10. Nominated persons

In accordance with Section 325 of the Companies Act, the right to appoint proxies does not apply to persons nominated to receive information rights under Section 146 of the Companies Act. Persons nominated to receive information rights under Section 146 of the Companies Act who have been sent a copy of this Notice are hereby informed, in accordance with Section 149(2) of the Companies Act, that they may have a right under an agreement with the registered member by whom they were nominated to be appointed, or to have someone else appointed, as a proxy for this meeting. If they have no such right, or do not wish to exercise it, they may have a right under such an agreement to give instructions to the member as to the exercise of voting rights. Nominated persons should contact the registered member by whom they were nominated in respect of these arrangements.

11. Website

In accordance with Section 311A of the Companies Act, the contents of this Notice, details of the total number of shares in respect of which members are entitled to exercise voting rights at the AGM and, if applicable, any members' statements, members' resolutions or members' matters of business received by the Company after the date of this Notice will be available on the Company's website at: http://vpcspecialtylending.com/.

12. Audit concerns

Members should note that it is possible that, pursuant to requests made by members of the Company under section 527 of Companies Act, the Company may be required to publish on a website a statement setting out any matter relating to: (a) the audit of the Company's accounts (including the auditors' report and the conduct of the audit) that are to be laid before the AGM for the financial year ended 31 December 2023; or (b) any circumstance connected with the auditors of the Company appointed for the financial year ended 31 December 2023 ceasing to hold office since the previous meeting at which annual accounts and reports were laid in accordance with section 437 of Companies Act. Therefore, the total voting rights in the Company as at 23 April 2024 were 278,276,392 votes.

14. Notification of shareholdings

Any person holding 3% or more of the total voting rights of the Company who appoints a person other than the Chairman of the AGM as their proxy will need to ensure that both they, and their proxy, comply with their respective disclosure obligations under the Disclosure Guidance and Transparency Rules.

15. Members' rights under Section 338 and 338A of the Companies Act

Shareholders meeting the threshold under Sections 338 and 338A of the Companies Act can instruct the Company: (i) to give shareholders (entitled to receive notice of the AGM) notice of a resolution which may properly be proposed and is intended to be proposed at the AGM; and/or (ii) to include in the business to be dealt with at the AGM any matter (other than a proposed resolution) which may be properly included in the business.

16. Further questions and communication

Under section 319A of Companies Act, the Company must cause to be answered any question relating to the business being dealt with at the AGM put by a member attending the meeting unless answering the question would interfere unduly with the preparation for the meeting or involve the disclosure of confidential information, or the answer has already been given on a website in the form of an answer to a question, or it is undesirable in the interests of the Company or the good order of the meeting that the question be answered.
